3 Payment Model, Belated Payments

3.1 Upfront Payments – Initial Declaration of Adherence

Payments are due upfront and within 14 days of receiving an invoice. Company will indicate its Initial Declaration of Adherence and Monitoring Body will only process the Declaration Initial Declaration of Adherence once it received the payment.

3.2 Due Date of Annual Payments

Annual payments are due by January 1st of each calendar year. Fees that are not paid until January 30th of each calendar year shall be considered belated, unless otherwise agreed.

3.3 Belated Payments

In case of belated payments, a general administrative charge can be imposed. The administrative charge shall be EUR 15.00.

- Principally, a Declaration of Adherence is made per Company indicating the services and products which shall be covered. There is no limitation in services and products, provided the multitude of services and products do not result in excessive deviating statements in the Data Pro Statement. There must not be more than five (5) products or services per Declaration of Adherence that require a deviating statement. If there are more than five (5) deviating products or services indicated in the Data Pro Statement, the price shall be multiplied accordingly. I.e., up to five (5) deviations EUR 749,00, six (6) to ten (10) deviation two times EUR 749,00, eleven (11) to fifteen (15) deviation, three times 749.00, and so on.
- ³ The material renewal of any Declaration of Adherence must be completed every twelve months. Payments are due per calendar year. For the avoidance of doubt: regardless of when a Company declares adherence or terminates its adherence, there will be no pro-rata deduction.
- ⁴ The hourly rate of SCOPE Europe is EUR 200,00 (excl. VAT). Invoices will indicate units per every quarter of an hour, i.e., 15min.
- ⁵ For the avoidance of doubt: In cases of an Initial Declaration of Adherence, the Monitoring Body will simply conclude negatively, providing the company with the possibility to re-submit subject to the fees at any time when the documentation is prepared more appropriately. In cases of an annual renewal, the Monitoring Body will provide every company free of charge with options to clarify its statements at least once. However, where a Company remains unclear in its responses, refuses to provide sufficient evidence, the additional efforts by the Monitoring Body shall be reimbursed.
- ⁶ The pricelist may be updated in cases the Monitoring Body faces repeatedly manifestly unfounded or excessively complaints.
- ⁷ Unjustified complaints shall be free of charge. In cases of a (partially) justified complaint, it remains to the discretion of the Complaints Committee to impose the costs for processing on the Monitored Company, where deemed proportionate.

¹ Micro and Small Companies are those companies with less than 50 employees (FTE); Medium and Larger Companies are those companies with 50 and more employees (FTE).
